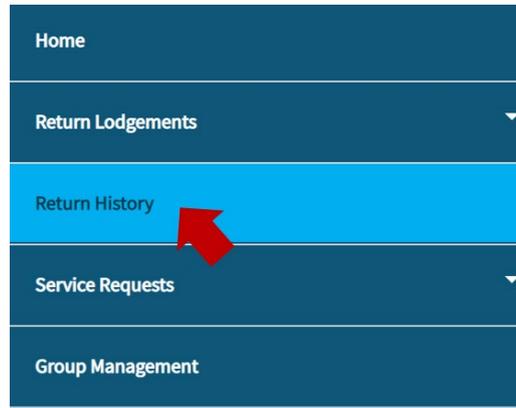


Amend a Return

Use this process to change a previously submitted monthly return **within** this financial year, or to amend an annual return up until 26 October.

Please note: If your annual return requires amendment after 26 October, please contact the ACT Revenue Office by completing the 'contact us' web form on our website

Log into the Self Service Portal, then navigate to **Return History** in the main menu.



The Return History screen will display a list of previously submitted returns. Click on **Amend** for the required return.

Monthly Return History
Periods prior to July 2016 will only appear if they have a non-zero balance.
