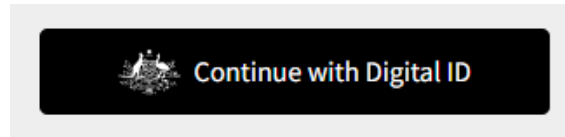
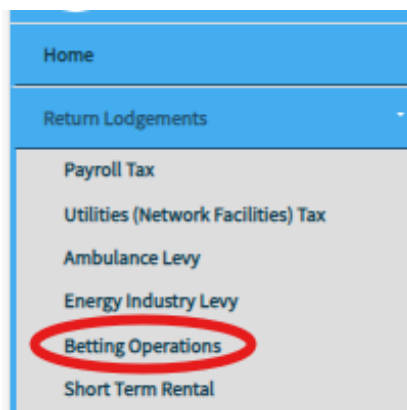


Lodge a Betting Operations Tax Return

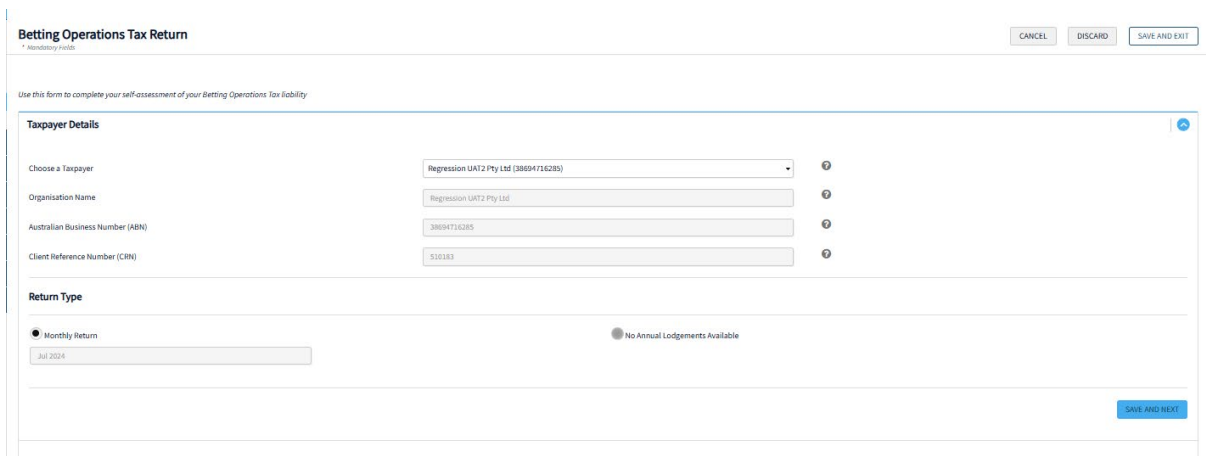
Log into the Self Service Portal.

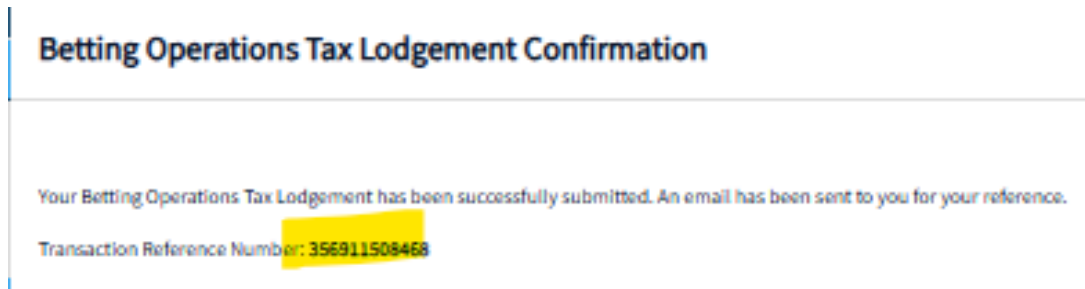

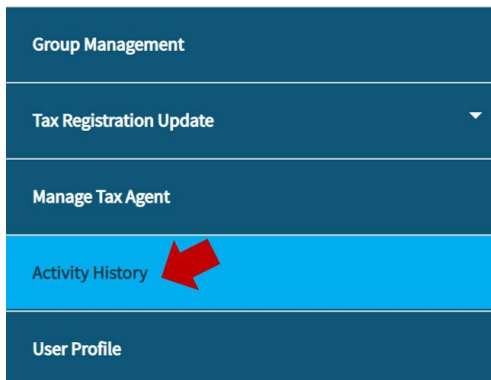
