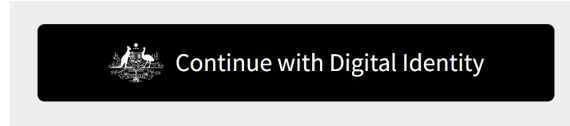


Lodge a Utilities (Network Facilities) Tax Return

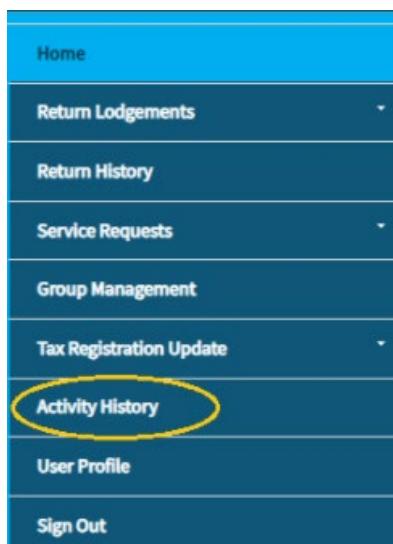
